1.	The society should take necessary steps to collect outstanding dues and interest for delayed payments from defaulting members..	Being compiled. All members having outstanding amount have been sent Notices/ letters. Legal action has been initiated against one chronic defaulter.
2.	It is observed that few members have not taken membership of the society, it is suggested to the management committee to encourage those members who are eligible to take membership should come forward and take membership of the society.	Suggestion has been noted .There has been minor increase in number of members due to consistent Persuasion. More is likely to be in the offing.

PART-B

WORKING OF THE SOCIETY :-

1. The society is functioning from its registered office situated at Plot No. 19, Sector-4, Dwarka, New Delhi-110078 and all the members are being allowed to inspect the documents of the society including audit report as per the provisions of Delhi Co-operative Societies Rules, 2007
2. Society reconciled its Bank accounts maintained with Punjab National Bank and ICICI Bank, Reconciliation statements of the bank accounts are attached with the report.
3. The society has no policy of advancing loan to the members for the purpose of payment for repair of house/flats leased out to the members and other allied needs. The society as such has not granted any loan to the members during the financial year under audit.



4. In view of the fact that Society has no debt, the debt-equity ratio is not applicable.
5. Managing Committee has implemented/carried out the decisions of the General Body. Necessary actions are being taken whenever required.
6. As per the explanation given to us, there was no unresolved disputes in the society at the year end, except those before the courts/arbitrators as per list attached.
7. There was no claim outstanding against the members and other outside parties except amount recoverable on account of regular maintenance & other charges of the Society.
8. No TDS has been deducted on the payment of Rs 45000 paid to Mosumi Printer on Nov/22/2025.
9. The Flats on the Society's land were constructed and allotted to the members in the year 2001.
10. During the year under audit, 16 Managing Committee Meetings were held on dates as mentioned in the annexure enclosed and the minutes of the same were also recorded and annual general body meeting was held on 5/10/2025.
11. Election of the Managing committee of the society was held on 12/10/2025 for a new three year Term.
12. As explained to us, none of the office bearers of the society suffer from the disqualification contained in Section 35 read with Rule 54 and 55.
13. List of members with the ledger balances at the close of the cooperative year is attached with this report.
14. The society has prepared budget for expenditure made during the financial year 2025-2026.
15. The society is periodically reviewing the fixed assets.
16. Certificate of cash and records maintained by the society is attached with this report. Also certificate by our firm regarding books of accounts of society seen by us during the audit is attached herewith.
17. The society has shares of DCHFC of society amounting to Rs. 5,000.00 at the close of the co-operative year.
18. During the year there was addition of Fixed Deposit amounting to Rs. 144825/- now total FDR as on 31st March, 2026 Rs. 21170420/

2. TDS should be deducted on the payment made to the water tanker suppliers.
3. The society should take necessary steps to collect outstanding dues and interest for delayed and interest for delayed payments from defaulting members.
4. It is observed that few members have not taken membership of the society, it is suggested to the management committee to encourage those members who are eligible to membership should come forward and take membership of the society.
5. No TDS has been deducted on the payment of Rs. 45000/- paid to Mosumi Printer on 22/11/2025 (DAKSHINAYAN PUJA SMITY)

Accounting Policies and Notes to Accounts for the year 2025-2026

Accounting Policies:

1. **Accounting convention and concepts** : The accounts for the year ended 31st March, 2026 have been prepared under the historical cost of convention in requirements of the Delhi Cooperative Societies Act. The Federation follows the mercantile system of accounting and recognized income and expenditure on accrual basis in the preparation of accounts.
2. **Fixed Assets** : Assets are recoded at cost less depreciation. The cost of assets includes all expenses incurred for acquisition of assets.
3. **Depreciation**: Depreciation on fixed assets is provided on written down value method on the individual items at the rates specified under the Income Tax Rules. No depreciation is provided on items sold during the year.
4. **Invesments**: Investments are stated at cost of acquisition. Investments are held as long term investments. Income on investment is accounting on accrual basis.
5. **Valuation of Stocks**: Value of closing stocks of stores and spares as also the Diesel are estimated.

Notes to Accounts

1. Electricity charges have been apportioned between the metered consumption & common area uses.
2. Bills for electricity consumption and materials issued in March, 2026 but billed on 01.04.2026, have been provided in accounts on 31.03.2026.
3. The Accounts of Dakshinayan Puja Samity for the year 2025-2026 are enclosed.



4. Figures have been rounded up to Rupees and re-arranged and regrouped where ever necessary.
